Sources said that the man came to **TRNC from TURKEY** for a holiday. The patients name is **Şevket Yılmaz**.

The police are now searching for him.

### Covid-19 Latest

The numbers of new infections seem to be increasing at the moment. The next 'challenge' will be when the UK finally drops to Category B in the W.H.O. rankings which will mean no quarantine and knowing the numbers of UK Citizens who wish to return this could possibly cause an increase.

As and when the UK moves into Category B, then we will circulate a 'Press Release' to our members.

### **GREEN LINE ISSUES**

We are well aware that the Greek Cypriot administration are using the current COVID-19 emergency as a reason to exclude anyone, other than GCs and some RoC permanent residents, from crossing from the South into the TRNC.

This is a flagrant breach of EU rules regarding Free Movement between both sides. Although there are isolated instances of Foreign nationals being able to cross the Green Line, it appears that these are being facilitated through the relevant Embassy teams.

We have received requests that we enlist the help of the British High Commission to assist UK nationals (Members) crossing the Green Line in order to catch flights that they have booked. The British High Commission has so far refused to assist in these requests which they do not see as 'for humanitarian' reasons.

They seem reluctant to upset the Greek Cypriot administration!

**Our advice is that until further notice if you are booked onto a flight to the UK from either Larnaca or Paphos OR planning to fly to either airport with the intention of travelling onward to the TRNC speak to your airline and explain you are being refused access to your destination. Hopefully, you will be able to reschedule the flights or obtain an 'open ticket' or refund, as for the time being your ONLY route to the TRNC is via Ercan.**

**If and when this changes we will inform you.**

### **FLIGHTS INTO TRNC**

**A SHORT CONCISE SUMMARY EXPLANATION IF COMING FROM THE UNITED KINGDOM AFTER 16<sup>th</sup> JULY.**

Due to the reduction in the number of cases in the UK, flights from this country to the island are expected to begin on **16 July 2020**.

From 16 July, people coming to the island from the UK will be able to take a PCR test **no less than three days and no more than five days** with a negative result before leaving the country.

A second PCR test will be taken upon entry to the TRNC . Passengers will then be quarantined for 7 days, at a TRNC designated quarantine facility, at the passenger's own expense.

At the end of the quarantine period, the passenger will take a third PCR test and if negative will be allowed to leave the facility.

## **QUARANTINE COSTS FOR 7 DAYS WITH PCR TEST - APPLICABLE FOR ARRIVALS AS FROM THE 16TH JULY**

We have just received confirmation from the Ministry of Health that the payment required in advance **(prior to departure)** is Accommodation including meals is 265TL per person per night x 7 = 1,855TL plus 300TL for PCR test. Total amount 2,155TL Confirmation of payment in advance will need to be produced upon arrival at Ercan airport.

If coming from a Zone C country, such as the UK, ensure that the payment for your quarantine and PCR test is made before departure. Then ensure that you carry a copy of the payment advice with you on the flight.

Print off and complete the TRNC Ministry of Health Information and Obligation Form, below. This consists of two pages. One completed form for each adult, children may be added to one of the adult's forms. Ensure that you bring these with you.

Upon arrival at Ercan airport, the necessary officials will be aware of your arrival in advance, through the flight manifests, which will also highlight any connecting flights that you have made, to connect with your final flight to the TRNC.

Only upon arrival at Ercan will your quarantine accommodation be allocated to you, according to availability. It will not be possible to know beforehand, where you will be accommodated.

## ANNUAL GENERAL MEETING

## UK PASSPORT RENEWAL

The following information was released via the BBC news today (21 July 2020)

- UKPO have suspended their Fast Track service
- Over a million passports would have expired during the lockdown
- To consider applying to renew a passport 9 months or more before expiry (no comment was made to those living abroad)
- UKPO cannot guarantee how soon renewals will be processed
- The backlog is increasing as lockdown restrictions are gradually being lifted
- Those who are applying for their passports for the first time are not being processed due Social Distancing rules as an Interview is required. Interviews are necessary based on security to avoid identity fraud.
- Skype is being tested but there is no guarantee of being taken up based on security reasons.
